3. Pricing & Availability

All prices are listed in U.S. Dollars (USD). We reserve the right to modify prices, discontinue artwork, or refuse or cancel orders at any time. If an item becomes unavailable after purchase, a full refund will be issued.

4. Payment

We accept secure payment methods through WooCommerce and authorized payment processors including Square, major credit cards, and other approved payment methods displayed at checkout. We do not store full payment information on our servers.

5. Shipping
